


REGISTRATION
TO ESTABLISH, MAINTAIN AND OPERATE
CLASS VALUE ADDED REGISTERED SERVICES IN PAKISTAN

The Pakistan Telecommunication Authority is pleased to register **Zecto Communication (Private) Limited**, Plot 466, Lane 08, Near Allied Bank, Multan Cantonment, for providing Class Value Added Registered Service as mentioned in "Class Licensing and Registration Regulations, 2007" to:

- a. Extend SMS Aggregator and Content Services to all, in a non-exclusive manner, free of all discrimination;
 - b. Abstain from providing any telecom service without obtaining a prior license; and
 - c. Promptly provide all information, as and when desired by the Authority, which helps it to quantify proliferation of the technologies or services, whether technical, regulatory, or financial in nature.
2. This registration is valid for a maximum period of five (5) years from **25th November, 2025**. In case the licensee wants to continue the licensed operations beyond five (5) years, a fresh application for registration may be submitted to the Authority in accordance with regulation 6 of Class Licensing and Registration Regulations, 2007, three (3) months before the completion of the expiry of the five years.
3. In case of allocation of numbering resource(s), **Zecto Communication (Private) Limited**, shall pay the numbering fees/charges in advance by 30th June each year on such terms and conditions as determined by the Authority from time to time. If the dues are not cleared by the due date i.e. 30th June each year, then the number resource will be withdrawn from 1st July of that year.
4. **Zecto Communication (Private) Limited** shall provide registered services in accordance with and in compliance with the laws of the Islamic Republic of Pakistan.
5. **Zecto Communication (Private) Limited** shall, in the course of provision of its services in the country, comply with the provisions of the Pakistan Telecommunication (Re-organization) Act, 1996, the Rules/ Regulations framed thereunder, and directions of the Authority, which may be issued from time to time.
6. Where the provision of this permission is silent or ambiguous, on any issue irrespective of its nature, the Authority's decision shall be final and binding.
